The right application

nvestment in innovation is the key to economic success, enabling businesses to remain competitive in the global marketplace and is part of the solution to exit from the economic crises. International cooperation is crucial to achieving many of the objectives of Horizon 2020. Involvement in the programme offers major benefits to those organisations engaged in research and who aim to move the frontiers of knowledge and technology forward.

For businesses and academia participating in grant funding programmes, this has many potential benefits including the opportunity to create collaborations across the public and private sectors and bringing together expertise in research. This is in addition to consortium members sharing knowledge, skills and experience at an international level. Involvement also opens up new contacts, networks and markets across Europe and enables organisations to be involved in ambitious and cutting-edge projects.

The new seven-year framework programme, Horizon 2020, officially launched on 1 January 2014 with fresh opportunities for research and innovation in three main pillars:

Excellent Science – this priority aims to raise the level of excellence in Europe and ensure a steady stream of world class research to secure Europe's long-term competitiveness. It will support the best ideas, develop talent within Europe, provide scientists with access to key research infrastructures, and make Europe an attractive location for the world's best researchers.

Industrial Leadership – this priority will aim to make Europe a more attractive location for investment in research and innovation (including eco-invocation) by promoting activities where businesses set the agenda. It will provide major investment in key industrial technologies, maximise the growth potential of European companies by providing them with adequate levels of finance and help innovate SMEs to grow into world leading companies.

Societal Challenges – this reflects on the policy priorities of the Europe 2020 strategy and addresses major concerns shared by citizens in Europe and elsewhere. A challenge-based approach will bring together resources and knowledge across different fields, technologies and disciplines, including social sciences and the humanities. The pillar will cover activities from research to market with a focus on new innovation-related activities, such as piloting, demonstration, test-beds and support for public procurement and market uptake.

Grant funding project applications

Preparing and developing a Horizon 2020 project proposal may seem daunting, especially given the volume of information and number of documents needed. For many organisations, the difficulties involved in

collecting the right information, writing the project proposal, submitting applications and managing the operation of the project will stop them participating in the programme. Some organisations have very little or no awareness of the funds available, whilst others may be put off due to a lack of knowledge, fear of bureaucracy, language problems or past experience.

Engaging with a consultancy that specialise within this area of grant funding and project management could be the answer.
